Focus of the 2021 Symposium will be to help attendees obtain continuing education credits for their state licensing boards. Due to logistics, networking opportunities are not guaranteed.

1. REGISTRATION FEE

There is no registration fee for ADURS-funded attendees (*State Delegate/Voting Member, Alternate State Delegate, Program Committee Member, Speaker, Director, Staff, or other as determined by ADURS*). Each state may have up to 2 sponsored attendees.

There is a \$100 registration fee for non-funded state attendees (Non-Voting State Delegate Additional), (registration fee covers educational programming – **cancellations must be made by February 12, 2021 for a full refund – no refund will be paid if after this deadline**). Fee may be remitted by check to ADURS, Inc. 3006 Edinburgh Drive, Edmond, OK 73013. Credit card payments will be processed via PayPal.

The 2021 fee schedule is as follows:

- State Attendee - Sponsored (no registration fee) – Up to 2 per state
- State Attendee - Additional (\$100 registration fee. If your state does not allow you to accept the ADURS sponsorship, please check this option.)
- ADURS Directors/Program Committee/Staff (no registration fee)
- Speaker (no registration fee)
- Association Representative (no registration fee - up to 2 per association; i.e. – PQA)

Please Note: Vendor state attendees must actively participate in state DUR to attend ADURS Symposiums.

2. CONFERENCE MICRO SITE

Speaker presentations will be located on our Symposium micro site, provided by our webinar host. The site should be available approximately one (1) week prior to the symposium.

All presentations will be pre-recorded with select speakers available for Q&A following their slides during our scheduled "Live" portion. "On-Demand" speakers will be available for Q&A via email only. Due to US Copyright Laws, downloading of slides from the micro site will not be permitted. Edited for Distribution slides/handouts will be available via login access on the ADURS website. You must have an active www.adurs.com account to access symposium information.

Slides will be available for viewing on the micro site for approximately three months. However, CE credit is ONLY available through Saturday, March 13, 2021.

3. CONTINUING EDUCATION

Continuing Education Applications must be submitted by **Saturday, March 13, 2021 by 11:59pm Central Time**. Only registered attendees may apply for CE credit. Applications submitted by non-registered individuals will be deleted without notice.

Alphanumeric codes will be assigned to each speaker presentation and must be entered into your CE application to obtain CE credit. CE credit will NOT be awarded for missing codes. You are responsible for the accuracy of all information.



The **2021 ADURS Symposium** is designed for pharmacists specializing in medication utilization within State Medicaid programs and is sponsored by the American Drug Utilization Review Society (ADURS) and the Nebraska Pharmacists Association (NPA). NPA is accredited by the Accreditation Council for Pharmacy Education (ACPE) as a provider of continuing pharmacy education. Credit for courses must be earned by the participant. Participants will earn **13.00 contact hours** of continuing pharmacy education (CPE) credits for attendance of the entire symposium.

In order to earn CPE credits, the participant must complete an on-line educational evaluation form for each CPE session they attend within 15 days from the end of the symposium. The evaluation will collect birthdates (MMDD) and NABP e-Profile ID numbers (to receive CPE credits, the attendee must have an NABP e-Profile ID number).
